

No, we're not that far out of touch. So why is Head Start still getting

hammered by a 2002 study that was done back when Friends won the Emmy, KISS was performing their final concert, the Seahawks were still at the Kingdome, and we barely knew what 'texting' meant? Head Start has made great strides since 2002 and we need to make sure policy makers and pundits understand that. Joel wrote a great blog that outlines some of those



changes and the recent research that contradicts the Head Start Impact Study. Read the whole thing here.

How does the 'McCleary Decision' affect ECEAP?



Everybody (at least everyone who's interested in advocacy) is talking about the McCleary Decision, in which the Supreme Court has told the legislature to find much more money for K-12 Education to meet our state's constitutional requirement. What does that mean for early learning and other programs that help our families? Well, it's not good.

The legislature needs to come up

with billions for K-12, so they either need to raise revenue (taxes, fees, close loopholes, etc) or cut other non-K-12 programs like early learning, housing, health, disabilities, TANF, food programs, etc.

Right now the state spends less than 1% of its budget on early learning,

which research has shown is a critical strategy for getting kids schoolready and making sure we get the kind of successes in the K-12 system that they're looking for. We're going to need to convince legislators that investing in quality early learning should be considered as important as investing in older kids. Check out our news release for more information.
